- ❖ Drinking water shall be chlorinated and maintained residual chlorine 0.2 to 0.5 PPM if any other water disinfection method is followed should have adequate documented maintenance.
- ❖ Overhead tanks and water sumps septic tanks shall be hermetically sealed and scientifically closed and shall not be breeding sources of mosquitoes.
- ❖ The water tanks in the campus should be kept clean by protecting it from mosquitoes, the wastage like plastic items, broken bottles, and unused tires should be replaced immediately from the rain water.
- ❖ This certificate valid one year from the date of issued.
- ❖ Thereafter it will be renewed by the management.
